MEET OUR NEW NATIONAL PRESIDENT

his year started on a sad note with the unexpected death of Tim McCombe OAM.. I think he would have been pleased to see how many veterans and other friends attended his funeral and the eulogies which indicated the very warm regard in which he was held.

My thanks to Bill Roberts for filling in as Acting President until my election on 25 June. From that day on I have had a steep learning curve. Graham

Walker, our veteran researcher, has been an enormous help to me. Without his mature insight and sound advice progress would have been painfully slow.

I have represented the Federation at the ESO round table in meetings with DVA. The SRDP Working Party was another task. Of interest was the appeal that Tim had started re Prostrate Cancer and which I took over with lots of help from Ross Dunn of our Canberra Branch.

Tim had spent many years trying to get smoking introduced as a factor in the Prostrate Cancer SoP. He succeeded and on 22 Oct 12 SoP No. 77 & 78 of 2012 introduced the smoking amendment. Imagine his surprise when less than 2 years later, new SoPs were introduced. Whilst the Operational Service SoP (51/2014) retained smoking as a factor, the non- Operational SoP (52/2014) had smoking removed as a factor. Ross and I attended the review hearing on Prostate Cancer on 31 July and put what we believe was a

strong case. Decision not yet received.

SRDP stands for Special Rate Disability Pension and is supposed to be the MRCA equivalent to TPI under the VEA. It is not equivalent because it is offset by the Commonwealth contribution to MSBS. In effect this means that almost always the actual SRDP compensation is zero and in some cases a negative sum. You will not be surprised to know that of those eligible for SRDP, some 170 personnel, only one has accepted the offer. The

ESO working party has suggested very strongly that the offsetting should cease. There is no connection between superannuation and compensation.

I met the new DVA
Minister, Stuart Robert, in
October. He is also the
Minister for Human
Services and the Minister
Assisting the Prime
Minister for the Centenary
of ANZAC. He will have
his work cut out to keep on
top of his Parliamentary
and Electorate workload.

Why so much trouble accessing Agent Orange Records.

Many Vietnam veterans were exposed to Agent Orange.

So you'd expect we should be able to get easy access to the DVA files on the subject that are the required age (15 years) for release.

No such luck.

It has been an unholy battle with most files still held at DVA even though their release dates were decades ago.

And, by law, these files must be produced no more than 90 days after a request is lodged. This has rarely been achieved.

Surely Vietnam veterans have the right to learn about their exposure and its consequences from these DVA files long past their release dates. Why the delay?

Is it inefficiency? Lassitude? Lack of respect for war veterans?

The National Archives is an important institution that is not providing the service to Vietnam veterans that morality expects and the law demands.

PRESIDENT'S REFLECTIONS

Hitting the floor running, the new National President, James Wain, has raised several questions with The Honourable Stuart Robert MP, Minister for Veterans' Affairs. We report here, the first of those enquiries, with a summary of recent slashes proposed and already implemented, affecting the Veteran community.

Dear Minister,

We were angry to learn that your government has cut yet another Repatriation benefit.

From July 2016, disabled war veterans and war widows will no longer be eligible for concessional travel on The Ghan.

This joins a shameful list of slashed benefits already implemented or announced:

- The government will reduce the pensions of more than 10,000 Part Service Pensioners and completely cut out the Service Pensions of some 2,800 others.
- The government has withdrawn its \$223million share of an agreement with the States to fund Service pensioners' concessions for travel, electricity, phone and council rates.
- The government intends to axe the three month backdating of Veterans Disability Pension claims; a very long standing concession giving some flexibility for delays in obtaining medical evidence and a recognition of the special nature of military service.
- It has axed the Seniors Supplement (\$876.20 a year) for Gold Card holders not receiving income support.
- It has cancelled the indexation of the Clean Energy Supplement added to Veterans Affairs pensions and payments, causing it to quickly lose real value.
- Military Superannuation not previously counted, now to be counted as income when applying for a Commonwealth Seniors Health Card.
- Some regional DVA offices are closing with clients sent to Centrelink.
- Some regional dedicated VVCS offices will close and staff at others reduced.
- The government tried (unsuccessfully thanks to an unimpressed Senate) to downgrade the indexation of the TPI, General Rate Pensions, Invalidity Service Pension, Age Service Pension, War Widows Pension, Income Support Supplement, wholly dependent partner payment. Whilst the Senate thwarted its attempt this time, will it be able to thwart it next time?
- The government has downgraded the quality of hearing aids available under SRCA.

Senate Inquiry into the Veterans' Affairs Legislation Amendment Bill 2015. (2015 Budget Measures)

During August/September 2015 the Government tried to introduce legislation through the Senate, which was bad for veterans.

The Senate held it up for an inquiry.

The following is our submission to that inquiry.

Inquiry into the Veterans' Affairs Legislation Amendment (2015 Budget Measures) Bill 2015.

his submission is made by the Vietnam Veterans Federation of Australia Inc. We represent some 6,200 Veterans, former and serving ADF Members and their families.

We strongly oppose the proposal in Schedule 2 of the Bill:

- a. to remove the option for internal reconsideration, by the Military Rehabilitation and Compensation Committee (MRCC), of a decision by the Department of Veterans Affairs (DVA) to refuse a Veterans claim for benefits under the Military Rehabilitation and Compensation Act (MRCA); and
- b. to allow only for a 'single pathway' review of that decision by the Veterans Review Board (VRB); and

This proposal is directly contrary to the recommendation by the recent Review of Military Compensation Arrangements (the Review), which recommended that the single pathway appeal process should involve internal reconsideration by the MRCC first, then the VRB process, and then the AAT, thus creating a faster and less costly process:

'The (Review Committee) believes that reconsideration by the MRCC should be the first step in the review process. This would help ensure the quality of decisions that are considered by the

VRB and reduce VRB workloads and costs' and would align with the review process under the VEA.

The Government claims that the proposed changes give effect to the Review recommendations. However, while implementing Recommendation 17.1 for a

single appeal path, the proposed amendments ignore Recommendation 17.2, i.e. for internal reconsideration by the MRCC to be the first step in this review process.

Instead, the proposed amendments will remove internal reconsideration by the MRCC from the appeals process altogether, so that the VRB review becomes the first tier of the single appeal pathway.

The Government has provided no explanation for its failure to adopt the Review's Recommendation

17.2 in full. However it might be surmised that the underlying policy of the more restrictive proposal is intended to have a twofold effect-

- 1. first, without explanation, it will in effect abolish the present long-standing arrangement, by which a Veteran may appeal an unfavourable internal DVA 's 349 decision' direct to the AAT; if successful there, the AAT is empowered to award costs in the Veteran's favour; by contrast, the AAT cannot award costs if the Veteran has appealed an unfavourable VRB decision. Plainly, the Government is concerned about the 'open-ended' scope for the AAT to award costs against DVA if the Veteran wins. The new policy will potentially save DVA money, but to the detriment of Veterans.¹
- second, perhaps less obvious but equally feasible in the general context of the opaque official explanation of this proposal, it may be that the policy is intended to 'nudge' Veterans away from seeking any review of any kind of an unfavourable decision. The 'nudge' concept is by now well-known and frequently used by governments in the Western world.² It is therefore not fanciful to speculate that by depriving Veterans of the present relatively straightforward process of seeking an internal review and thereby 'nudging' them into the more complex process of the VRB, with no prospects of a favourable costs order on appeal to the AAT, the policy is intended to discourage appeals against DVA decisions. Once again, this is to the detriment of Veterans.

The Minister for Veterans' Affairs has stressed the support of the ESO Round Table (ESORT) members for the Government proposal. I have dissented from the ESORT decision to support the proposed amendment. I now suspect that the ESORT has also been influenced by 'nudge' tactics.

Our members are dismayed and in many cases, angry, about those proposed changes, and also about the opaque and disingenuous method of their presentation and explanation.

It is our submission that the Committee should-

1. recognise the disproportionate and seriously

adverse impact of the present proposal upon Veterans, and

2. recommend that the Government abandon the proposal and instead implement the full recommendation by the recent Review of Military Compensation that the single pathway appeal process should involve internal reconsideration by the MRCC first, then the VRB process, and then the AAT, retaining the right to have costs awarded if successful at the AAT.

The Minister agrees something should be done but nothing is happening

eturning troops from fighting wars and peacekeeping can suffer from Post Traumatic Stress Disorder and other psychological conditions.

Readers will know that this can sometimes disrupt family life.

In fact, we know from a recent study that the children of Vietnam veterans have high rates of psychological distress and we know from a previous verified study that they have a 300% higher suicide rate than their peers in the general community. We

also know from a recent study that the wives of Vietnam veterans have much higher rates than their peers in the Australian community of thinking about, planning and attempting suicide.

So intervention as soon as a veteran's

behaviour begins to disrupt the family is vital if long term suffering (and huge cost in the longer term) is to be prevented.

So there must not be any disincentive or obstacle to a veteran's partner getting counselling at our Veterans and Veterans Families Counselling Service (VVCS).

But what if she has a 3 year old and a 5 year old or even a 6 year old and no nearby family or neighbour or other young mother to mind them while she seeks VVCS help.

The consequences of the unavailability of childcare preventing the young mum having counselling could be, in the longer term, a family disaster.

The Minister says something should be done about the situation, but nothing is happening.

Why not?

Is the Repatriation Commission continuing to sit on its hands?

Disapproval of the idea has, in the past been justified by claims that young mums might use the service to go shopping (which is hardly a vote of

needed because some VVCS offices do sometimes make once-off costless arrangements (such as having several young mums counselling on the one day, each looking after the other's children). Of course this simply means that there is a demand).

But uncertain casual arrangements at some VVCS offices sometimes is not good enough. Certainty is essential.

If face to face counselling is the best clinical option there must be certainty of child care so there is a guarantee that it can be delivered.



The Repatriation Commission says that, if child care can't be offered, the young mum will have to accept the inferior option of telephone counselling. But the danger of family dysfunction and its tragic consequences is too serious for second-best solutions.

The Minister has said something must be done. Let each VVCS office work out its own solution to be able to guarantee child care if needed and have a fund available if costless solutions can't be used.

And if this certainly encourages only one or two young mums to quickly find VVCS help who would otherwise not have done so, having funded arrangements in place would be totally justified.

We do not want a repeat of the tragic family aftermath of the Vietnam war.

Amalgamation concerns

President, James Wain wrote to the Prime Minister to seek assurances that the DVA would not be disbanded, with all Veterans' administered by 'Human Resources Department', (Centrelink by any other name).

Dear Prime Minister

The Hon Stuart Robert has been made the Minister for Veterans Affairs and the Minister for Human Services. We note that his military background will be an asset in helping him to get across Veterans issues.

However being responsible for two portfolios concerns us. Sections of the government and some other organisations have for years advocated the disbanding of the Department of Veterans Affairs with its responsibilities taken over by the Department of Human Services (or its predecessors).

We note too, that the Hon Dr Peter Hendy has been promoted to Assistant Minister for Productivity. When Chief Executive, Australian Chamber of Commerce and Industry, Dr Hendy promoted a paper meant to influence government policy titled Commonwealth Spending (and Taxes) Can Be Cut --- And Should Be. The paper advocated that the Department of Veterans Affairs be disbanded with disabled war veterans and war widows administered by various departments such as Welfare and Health.

We would appreciate an assurance that an amalgamation of the two departments is not contemplated.

Government's attack on the Service Pension.

It's part of the larger government attack on disabled war veterans' benefits.

Just because nothing much has been heard about it lately, doesn't mean it's gone away.

And indeed it hasn't.

he Opposition, Greens, Senator Jacqui Lambie and some other independents blocked the Government's attempts to seriously downgrade Service Pension indexation, so they slipped this one through instead.

In 2017, only a bit more than a year away, the Service Pensions of more than 10,000 veterans will be reduced and some 2,800 will be cancelled.

In danger are those veterans whose Service Pension now or in the future is calculated on the Assets Test.

A change will commence in 2017.

Currently, the Service Pension is reduced by \$1.50 for every \$1,000 worth of assets held above a means-test free threshold. The government intends to double this reduction to \$3 for every extra one thousand dollars of assets.

Is this fair?

On 9 May 2006 when reducing the taper rate from \$3 to \$1.50, the then Treasurer, Hon Peter Costello, gave this explanation:

"The current taper rate of \$3 means that a retiree loses more age [Service] pension than

they earn on their additional savings if they do not achieve a return [on their assets] of at least 7.8 per cent a year. This is a large disincentive to save for retirement."

The question is this:

Are Service Pensioners likely to achieve a return of 7.8% on their savings?

The answer is:


"Mostly, they'd have to be dreamin".

They'd be lucky to get 4%.

And it gets worse.

eaders will know that since the publication of the official history's version of the Agent Orange controversy in 1994, the VVFA has been campaigning for it to be rewritten.

Readers will know the reason for this is that the official history's version wrongly defends Agent Orange as harmless and accuses the veterans who campaigned for its harmfulness of dishonesty and greed. Nothing, of course, could be further from the truth.

Of course, we know for sure that exposure to Agent Orange is potentially harmful and that the veterans campaigned to support their sick and worried comrades in the best ANZAC tradition.

For years the Australian War Memorial ignored or dismissed out of hand our carefully argued case for a new official version that told the truth. Indeed our carefully argued case in letters to the AWM went unanswered. This was their frustrating defence; the 'wall of silence'; a time honoured tactic of large organisations against minnows like

us. It is a tactic often based on the good chance that a relatively un-resourced, volunteer organisation like ours will eventually run out of steam and go away.

But we did not give up. We kept hammering away.

Many of you will have seen our petition and our magazine articles pushing our case.

The breakthrough came with the announcement that Dr Brendan Nelson would be the next AWM director; taking up his appointment in December 2012. Brendan was Australia's ambassador to the

European Union, and before he returned to Australia we sent him our case. We were delighted at his response, inviting our President Tim McCombe and Research Officer Graham Walker to meet with him on taking up his new post.

This was the breakthrough we needed. It led to our Research Officer being invited to address the AWM Council. We had broken through the 'Wall of Silence'.

The War Memorial Council saw the injustice just as we did and ordered the commissioning of a new official history on the health and medical legacy of the Vietnam War, including of course, the Agent Orange legacy.

Dr Peter Yule, a Melbourne academic has been commissioned and given three and a half years to complete the job.

We hope it will be an improvement of the last lamentable effort and indeed we have every confidence it will be.

Effects of the Revised Assets Test

Revision of the Assets Test for the Service Pension

On 1 January 2017 a revised Assets Test will result in some 2,800 veterans losing their Service Pensions.

One of our members is a Part Service pensioner who also receives a 50% disability pension. He was granted a Gold Card several years ago on the grounds he is in receipt of both a 50% disability pension and a Part Service Pension.

When the revised Assets Test is introduced and he loses his Part Service Pension, will he also lose his Gold Card?


The loss of the Part Service Pension and Gold Card also means the loss of discounts on Council and Water Rates, Driving Licenses, car registration, and rental assistance etc.

Dear Frank

Thank you for your letter to Jennifer Collins, Deputy Commissioner NSW & ACT, dated 6 July 2015 concerning the revised Assets Test to be introduced on 1 January 2017. Jennifer has asked that I respond on her behalf.

As announced in this year's Budget, the assets value limits and the taper rate used to determine the rate of service pension will change from 1 January 2017 to improve the fairness and sustainability of the pension system. Rebalancing the assets test parameters will involve increasing the assets test free areas and the taper rate by which a pension is reduced once the free areas are exceeded.

Those whose pension is cancelled on 1 January 2017 as a result of this measure will automatically be issued with a Commonwealth Seniors Health Card or, for those under the pension age, a Health Care Card, without the need to meet the usual income requirements.

Veterans whose service pension is cancelled on 1 January 2017 as a result of this measure will retain their Gold Card.

DISABLED VETERANS STRUGGLE TO SURVIVE ON MEAGRE GOVERNMENT COMPENSATION

n April of this year the Australian Federation of Totally and Permanently Incapacitated Ex-Servicemen & Women wrote to the Prime Minister and asked that the Special Rate/Totally & Permanently Incapacitated (SR/TPI)

Compensation be adjusted to reflect today's standard of living.

The Federation is asking that the most disabled Veterans in the community be allowed to live in dignity and with some self-esteem by having the SR/TPI Compensation increased to 100% of the average weekly wage. It is currently at 43%. This has diminished over the past 65 years from 80% to 43%.

This is a deplorable situation for our most affected Veterans. This explains a number of things —

- the number of Veterans who are homeless,
- the number of Veterans' whose spouses/partners must work in order to bring in a worthwhile income for them and their children.
- the number of Veterans who cannot afford the ever increasing cost of living especially electricity costs.
- the number of Veteran and Civilian organisations who are relied on to provide the very services that the Government should be providing,
- and the number of Veterans who cannot hold their heads high with the proud knowledge that they have done their country proud and that the Government will look after them.

It is most disappointing that at this time of immense fiscal wastage that the Government cannot find less than half of 1% of GDP to look after those who have already looked after them.

The Other Side of the ANZAC Story

A burst of TV and other media stories about WWI has accompanied the Centenary of ANZAC eulogising the fine soldiering, endurance and sacrifice of our armed forces. Some focus too has been on Australia's General Monash, perhaps the finest general to have commanded on the Western Front

And so we should eulogise that effort and sacrifice.

But there is another side to the story that is often missed, it is the side of the story that is less told but it is the reason VVAA and the

VVFA, came into existence.

It is a side that has it's parallel after the Vietnam War.

This article is taken from an address by our National Research Officer, Graham Walker AM on 5 and 30 August 2015.

(There are few good references to the Australian aftermath of WWI. One that I am particularly indebted to for this talk is Michael Tyquin's Madness in the Military.)

t was 1914 and on the Western Front an epidemic, slowly at first, began its spread. The epidemic was new, little understood and, to the military, bewildering and frightening. This was the epidemic of Shell Shock.

Soldiers began streaming from the front line with a variety of symptoms. The least severe were such things as unfocused anxiety, depression, startle reaction, inability to concentrate, inability to reason, insomnia, nightmares, feelings of intense fear, panic attacks and shaking. More serious were

symptoms such as paralysis of the limb, blindness, fits, inability to speak, speaking reduced to a whisper, stammering and amnesia for which no physical cause could be found.

The less serious symptoms matched those of 'neurasthenia' whilst the more serious matched those of 'hysteria' [now termed conversion disorder]; both mental conditions.

Often these symptoms followed intense artillery bombardments.

Michael Tyquin in his book *Madness in the Military* gives some examples from the military record.

In one example a soldier, over a period of a year, was buried and dug out after artillery barrages, four times. He was described as 'Expression anxious, general tremor of head and limbs'.

Another had been part of a group of ten men blown up during an artillery barrage and had found himself the sole survivor. He told his doctor that 'all I know of France in what I dream'. He complained of

headaches and spoke with a stammer. His body was so tremulous that he was forced to walk with a stick.

Neurasthenia and hysteria were thought of in those Edwardian times as 'unmanly', particularly hysteria, which had been thought to be confined to women.

So, at first, a theory that the cause of these symptoms was the concussive effects of nearby artillery-shell-explosions, resulting in microscopic lesions on the brain, became popular.

But this as the only cause of Shell Shock had to be dismissed as more and more soldiers who had not

to man the trenches continually depleted by staggering casualties, tended to interpret the symptoms as malingering and cowardice. At the very least the military judged the sufferers to be moral

suffered concussion, presented with the symptoms.

That these symptoms could be psychological injuries had to be faced.

But the Military, desperate for men to man the trenches continually depleted by staggering casualties, tended to interpret the symptoms as malingering and cowardice. At the very least the military judged the sufferers to be moral degenerates. The medical profession, on the other hand, saw Shell Shock as real psychological illness but judged the sufferers as predisposed through genetic weakness.

In either case, the fault lay with the soldier. Both the military and the medical profession quarantined the sufferers as lesser beings, deprived of their manhood.

Of course, there were, no doubt, those individuals who were more prone to suffer Shell Shock than others. But the more important truth that failed to escape the taboos of Edwardian masculine culture was that no one was immune from Shell Shock. The more important factor was not individual predisposition but the severity and frequency of the shock.

And whilst it was understandable that there

would be a number of such cases the question remained, 'why the epidemic?'.

In retrospect we can perhaps see the reason. Instances of Shell Shock were not caused by some exceptional occurrences, they were caused by the very nature of the war. WWI, if not the first 'industrial' war, was certainly the first of such scale and intensity. The individual soldier was dwarfed by the great feats of industrial production particularly the devastating effect of modern massed artillery and the withering effect of the machine gun. And there was little manoeuvre. The soldier felt trapped

in his trench waiting for Armageddon in the form of the next artillery salvo. The combination of these, caused a feeling of helplessness. It is interesting that there were very few cases of Shell Shock on the battlefield amongst the Australian Light Horsemen in Palestine where the troops were constantly on the move and where the individual felt his courage and perseverance could make a difference.

During and after the war, the troops returned home to a sympathetic but uncomprehending public. That public had been fed media reports of the feats of the strong, resilient, inventive, good-humoured, laconic and selfless ANZACs. Of course the public understood the plight of the physically maimed and disabled, but they knew

little about the often invisible wounds of Shell Shock.

This ignorance was later reinforce by the official historian, CEW Bean, who in his many volumed official history made very little mention of Shell Shock and who, in his widely distributed Anzac Book excluded contributions not reinforcing the appealing side of the ANZAC story.

And what of the official view?



To say the least it was confused.

The authorities certainly had to look after those returning home with Shell Shock but many expected the symptoms would cease in the benign home atmosphere. But not only did most sufferers not recover but over time numbers of those returning apparently in good mental health, succumbed. Some in authority pointed to over indulgence in alcohol, marriage breakdown and other disappointments as the real cause of the returned soldiers' delayed symptoms, failing to realise that these unwelcome events themselves

could well have been caused by the underlying war damage. And the official view that predisposition or moral weakness separated those inflicted from those who were not, persisted. It is not surprising then, that though it was more generous than in some other countries the repatriation system was accused of cases of treating genuine sufferers as malingerers and denying them deserved pensions

In this climate of public incomprehension and official scepticism, it was often left to the households to carry the burden.

Marina Larsson, in her book *Shattered Anzacs*, gives some examples.

"In 1917 Mrs D Brown married Albert Brown, a

paranoid that 'someone was working against him'...But it was not till 1928, [some eleven years after his return] that Albert was admitted to ... [hospital] ..."

Sometimes, the returned soldier was not so passive.

"After his return, Gerald Muir regularly vented his rage at the family, as Joyce recalled: '[Dad] would fly into this temper, and he destroyed so many houses, and our belongings...he'd pull the electric light fittings out, he'd smash every piece of crockery in... the house... he'd throw a pot of tea... over the curtains and things like that. He went crazy..."

Sometimes the violence of the returned soldiers was turned onto the family members.

The Repatriation Department, however, did not see physical violence against the family as any of its

business, declaring it to be part of the veteran's 'private life'. In fact the family itself was not seen as part of the Department's responsibility.

In the spirit of Billy Hughes' promise of 'A Land Fit For Heroes' the Federal government established the Soldier Settlers Scheme inviting returned soldiers to take up farm blocks and offering seemingly attractive loans. Some 40,000 took up the offer in the early 1920s.

The scheme was a debacle.

By 1928 one third of the veteran settlers had abandoned their selections. In Victoria, by 1939, 60% had left their blocks most joining the unemployment queues in the cities.

What were the reasons for the failure?

Government enquiries found that some of the land had been of poor quality, the blocks were too small to be economic, and too many settlers with no farming experience had been selected.

With this insubstantial base, falling agricultural prices had

destroyed their hopes.

On top of this, one enquiry identified 'war disability' as a significant cause of the scheme's failure. Indeed, a large percentage (40% in Victoria) of the settlers had war caused disabilities including Shell Shock.

Marina Larsson recounts one such situation.

'Despite being discharged from the army as 'medically unfit' and receiving a small pension, John Watson, in 1919 was allocated a block... By 1922 John's health had declined to the point of admission to hospital. His wife Mary, took over the running of the block. Thinking John would return she carried on alone at the same time looking after eight children. But John died in hospital. Mary realised she could not continue alone but the block's debt was over £550. Her pleas to the Board

that the failure was not due to lack of effort but to John's war caused illness were headed but she left the block penniless.'

Canberra artist Katy Mutton has recently exhibited art works reflecting the despair felt by many Shell Shocked settlers and their families on the Red Cliffs settlement near Mildura. Her gathering of family recollections and letters includes many stories of drunkenness, family violence and suicide.

Vietnam was a different kind of war for most Australian troops. They were not subjected to frequent artillery barrages, nor were they static. Constant jungle patrolling kept them on the move. The result was that psychological casualties on the battlefield were few.

But the Vietnam War did have its own stresses.

It was guerrilla warfare. There was no front line behind which there was safety; there was always the danger of ambush, booby traps and stumbling onto camouflaged bunker systems.

Indeed it was estimated that in a 12 month tour of duty in Vietnam an infantry soldier would have felt his life in

danger for ten of those months. This has been compared with a soldier leaving Australia with the second AIF and returning 6 years later having felt his life in danger for round six months.

Then there were those particularly nasty jumping jack mines which would leap a metre into the air before exploding sending shrapnel for 100 metres; mines lifted by the enemy from our own 25,000 strong minefield. A tragedy in itself.

There were frequent small engagement as well as the big battles such as Long Tan.

And who were we fighting? The villagers we were there to protect could be, and in fact often were, the enemy.

The effect of these stresses rather than being

exhibited on the battlefield, was delayed so that the aftermath of the Vietnam War became similar to that of WWI.

One such similarity was that, until 1980, Vietnam veterans suffered the indignity of being told their psychological problems resulted from their own weakness; the diagnosis often being a pre-existing personality disorder.

Thankfully, in 1980, the authoritative US Diagnostic and Statistical Manual of Mental Disorders or DSM, introduced the diagnosis of Post Traumatic Stress Disorder or PTSD, a psychological condition with an external traumatic cause; one not requiring a sufferers' predisposition.

But regardless of who or what was to blame, Vietnam veterans like their WWI grandfathers, suffered a flood of delayed mental distress.

A recent examination of the Repatriation records of every one of the 60,228 army, navy and airforce Vietnam veterans over a 43 year period, showed almost half (47.9%) had an accepted claim for a mental health condition, mostly Post

Traumatic Stress Disorder but including such conditions as anxiety state, depression and substance abuse. The percentage for those involved directly in combat would likely be greater.

Another related statistic is that of the approximately 50,000 currently surviving Vietnam veterans, some 21,500 have been categorized as Totally and Permanently Incapacitated. Whilst there is no published statistic on the primary condition causing total incapacity, experience tells me it would probably be psychological conditions including Post Traumatic Stress Disorder.

Recently statistics have emerged from a Sydney University study on 'suicidality' of Vietnam veterans and their partners."

'Suicidality' is not a count of completed suicides. It

has three aspects to it; 'thinking about suicide', 'planning suicide' and 'attempting, suicide.

The findings are alarming.

Amongst Vietnam veterans, the risk of 'thinking

about' suicide is 7.9 times higher, 'planning' suicide 9.7 times higher and 'attempting' suicide 13.8 times higher than amongst their peers in the general population.

In such studies an increased risk of say 0.5 is considered significant. So these figures are tragically huge.

One difference between Vietnam veterans and their

grandfathers was that Vietnam veterans were less inhibited about making public their distress. They demanded their problems be fixed.

I became involved with the Vietnam Veterans Association in 1981. It was in those days something of a rag-tag organisation operating from a less than salubrious office in Parramatta. There, help was offered to Vietnam veterans including counselling by three volunteer qualified counsellors. Case studies from these sessions accompanied a submission to government successfully arguing for the establishment of a shop front counselling service. In 1982 the first of many offices of the Vietnam Veterans Counselling Service opened in Adelaide.

From this experience, those veterans realised that it was not just Vietnam veterans who were suffering, but also their families. This realisation led to the organisation advocating for recognition of the effect on families as well as the war's effects on veterans.

Confirmation of this concern has come from government sponsored studies over the past fifteen or more years.

A 1998 a government study found veterans' partners suffered high rates of psychological

distress.iii

Alarming statistics have emerged from that recent Sydney University study on 'suicidality'.'

For the wives the risk of 'thinking about' suicide is

6.2 times higher, 'planning' 3.5 times higher and 'attempting suicide' 6 times higher than for their peers in the general community.

From the year 2000, comes an even more alarming statistic. A government study v showed the children of Vietnam veterans suffering a suicide rate 300% higher than their peers in the general population. The main

cause was family dysfunction caused by the psychologically damaged veteran husbands.

After that finding, it was not surprising that the recently published Vietnam Veterans Family Study found higher rates of psychological illness amongst the children. Vi

It's was the same old story; the rerun of an old movie.

But looking forward we wonder how our Repatriation Commission and government will

handle the inevitably similar situation faced by our veterans returned from Timor, Iraq and Afghanistan and the similar situation of their families.

On their present performance, there is reason for pessimism (see the July 2015 edition of the VVFA magazine).

ALLIED FORCES

Service Pension and Membership entitlements

here are provisions within the Veterans' Entitlement Act, 1986 (VEA), for allies of Australia during World War Two, and the wars/conflicts that followed, to apply for a Service Pension (equivalent to the "Old Age" Pension from Centrelink), through the Department of Veterans' Affairs (DVA), provided that they have satisfied all the DVA and Government requirements for that pension.

I am aware from my conversations with a number of our members and readers of the Association's quarterly Journal, that many are unaware of the assistance that the Association also provides to the former "Allies" of the wars and conflicts that Australia has been involved with. These allies (post WW2) included South Korea, South Vietnam, New Zealand, America and the Philippines, and now a number of others, following Australia's recent deployments.

From about 1994 our Association has had an "open door" policy, and have assisted Australian veterans of all wars/conflicts, Peacekeeping/Making deployments and past and current serving members of the Defence Force, with disability pensions and welfare matters, at no cost to them and with no requirement to be a member.

Since then we have also assisted our "allies" with their claims for Service Pension entitlements and some welfare matters. Please note that the allied veterans are only entitled to claim for the Service Pension, and not the Disability Pension.

I might also point out that under the Association's Constitution, allied veterans are entitled to join the Association as "Ordinary Members", and many have done so, not dissimilar to RSL Sub-Branches.

In appreciation of our assistance to them, the "South Korean Vietnam Veterans Association" and "South Vietnamese Vietnam Veterans Association (ARVN)" in particular, have, over the years, and continue to do so, held various "functions and ceremonies" where monies raised have been donated to our Association to help us to continue our assistance to all Australian and allied veterans. Some of the donations have been quite substantial, and very much appreciated.

A considerable number of our South Vietnamese and South Korean members, who receive our Journal, are unable to read English, but would still like to receive advice or information, preferably in Vietnamese or Korean, of special events or important Government issues affecting them.

As they are members and have supported the Association for many years, by way of monetary donations, and in other ways, I believe that it would be reasonable and prudent of the Association to include in our Journal, when required, information/advice in the Vietnamese or Korean language, in our Journal or by way of a "flyer", or a separate mail-out, on those occasions.

SCHOLARSHIPS FOR OUR CHILDREN

ur readers would be aware that this Association, which is affiliated with the Vietnam Veterans Federation of Australia, has for many years funded Scholarships for children or grandchildren of Vietnam Veterans and also Peacekeepers and Peacemakers, who are struggling on their Repatriation Pensions and do not have the spare financial resources, or are in necessitous circumstances, to help these children through tertiary education.

Presently the Association provides funding for two Scholarships – "Tim McCombe OAM Scholarship", named in honour and memory of Tim, who passed away in January this year, and was a long serving and much loved and respected President of the Association/Federation. The "Phil Thompson OAM Scholarship" was named in honour and memory of Phil who was a founding member and highly respected former President of the Federation who passed away more than 20 years ago. These Scholarships are available nationally and parental membership of the Association is not a requirement.

The Scholarship provides for funding of \$3,000 per year for three years, provided that the recipient continues to meet the eligibility requirements.

The Scholarships are mainly funded from the proceeds of the **Association's Annual Raffle".** Your continued support of this Raffle would allow us to continue to assist these children with Scholarships and is be very much appreciated.

The Scholarships are administered on the Association's behalf by the "Australian Veterans' Assist Trust (AVCAT)", who also administer other scholarships funded by the Australian Government (Long Tan Bursaries), and sponsors such as Legacy, RSL, TPI and a number of other organisations.

AVCAT usually calls for applications for Scholarships in August of each year, with a closing date of 31 October of the same year. The

Unintended Consequences of Medical Treatment. A story of a good outcome to a real nightmare.

BACKGROUND

In early July 2012 an Army Reserve soldier had an inoculation. He had been for a medical and was informed that he had not had all the inoculations needed by the Army. He refused all the injections needed for deployment but agreed to the tetanus shot because he worked on his small farm. However there was no option available in the Medical Centre for a single tetanus shot. There was only a triple antigen i.e. tetanus, whooping cough and diphtheria. He was told by the nurse administering the injection that it 'would knock his immune system around': it did.

Within 24 hours he developed glandular swelling and swollen lymph nodes. He could not raise his arms and was off work. He had flu like symptoms and a whitish covering on his tongue and his gums. By August he had mouth ulcers. In October he developed Oral Thrush. In early 2013 the symptoms flared up again. By July he had developed lymphadenopathy:

Lymphadenopathy or lymphadenitis refers to lymph nodes which are abnormal in size, number or consistency, and is ofter used as a synonym for swollen or enlarged lymph nodes. Common causes of lymphadenopathy are infection, autoimmune disease, or malignancy.

This occurred in the left arm pit. He also developed fatigue and some loss of balance. In

2013 Oral Thrush and mouth ulcers were diagnosed as Gingivitis (Gum Disease).

In March 2014 he was diagnosed with Lichen Planus:

Lichen planus (LP) is a disease of the skin and/or mucous membranes that resembles lichen. The cause is unknown, but it is thought to be the result of an autoimmune process with an unknown initial trigger. There is no cure.

In November 2014 he was diagnosed with Chronic Fatigue Syndrome:

Chronic fatigue syndrome (CFS) is a complex medical condition, characterized by long-term fatigue and other symptoms. These symptoms are to such a degree that they limit a person's ability to carry out ordinary daily activities. CFS may also be referred to as systemic exertion intolerance disease (SEID), myalgic encephalomyelitis (ME), post-viral fatigue syndrome (PVFS), chronic fatigue immune dysfunction syndrome (CFIDS), or several other terms.

[3] Quality of life of persons with CFS can be extremely compromised.

Because of the long period of these significant conditions he developed Adjustment Disorder with Anxiety:

An adjustment disorder (AD)

(sometimes called exogenous, reactive, or situational depression, occurs when an individual is unable to adjust to or cope with a particular stress or a major life event. Since people with this disorder normally have symptoms that depressed people do, such as general loss of interest, feelings of hopelessness and crying, this disorder is sometimes known as situational depression.

THE CLAIM

The members initial claim on the Department of Veterans' Affairs (DVA), in March 2015, for Gingivitis, Lichen Planus, Chronic Fatigue Syndrome and Adjustment Disorder with Anxiety was rejected by a delegate under the Military Rehabilitation and Compensation Act 2004 (MRCA).

THE APPEAL

The member came to the ACT Branch of the Federation, situated in the suburb of Page branch, for help with an appeal to the Veterans' Review Board (VRB). The appeal was lodged under section 29 of the MRCA - this section covers unforeseen consequences of medical procedures. The research to support the appeal was carried out entirely by the claimant. He was diligent, thorough and painstaking in his efforts to unearth medical research that linked his physical reactions to the inoculation and his subsequent psychiatric condition.

When the appeal was lodged with the VRB, a request was made that it be reviewed under the Alternative Dispute Resolution (ADR) process, which has been trialled in NSW and the ACT this year. This process enables a single member of the VRB to review the case 'on the papers'. That member only has two options. One is to uphold the appeal, by setting aside the decision of the original delegate and direct DVA to accept the conditions claimed. The other option is to advise the claimant, that a decision can't be made on the papers and refer the appeal to full hearing of the VRB. A single member does not have the authority to reject an appeal.

On 25 Nov 15, a single member, decided to uphold the appeal and asked the claimant if he accepted that decision. He did and a written decision has since been sent to him. He did not have to attend a hearing. Thus an end to the laborious process of a claim and ultimately a successful appeal.

NEXT STEP

We now need to lodge a claim with DVA for the financial loss arising from losing his job. Hopefully we will be able to provide more good news in the next issue of the magazine.

V C E S NEWS & UPDATE

The Veterans' Children Education Scheme (VCES) and the Military Rehabilitation and Compensation Act Education and Training Scheme (MRCAETS) provide financial assistance, student support services, guidance and counselling for eligible children to help them achieve their full potential in full-time education or career training. The schemes cater for children undertaking primary, secondary and tertiary study and are normally provided only for full-time study within Australia.

In each State there is a Veterans' Children Education Board (VCEB) and a Military Rehabilitation and Compensation Act Education & Training Board (MRCETB) responsible for assisting with the administration of the Education Schemes. Board members serve in an honorary capacity and include respected members of the community experienced in matters relating to the welfare and education of children. The Board oversees each student's progress and provides educational guidance and counselling where necessary.

Under the VCES, an eligible child is someone who is:

- under 16; or
- between 16 and 25, undertaking full-time education; and
- the child of a veteran or a present or past member of the Australian Defence Force who is receiving (or was receiving prior to their death) a disability pension:
- at the special rate (commonly known as T&PI);
- at the extreme disablement adjustment (EDA) rate;
- at an increased rate because of multiple amputations, or multiple amputations and blindness; or

- the child of a veteran or a present or past member of the Australian Defence Force (ADF) whose death was war or defence caused; or
- the child of a veteran who was an Australian prisoner-of-war and is now deceased.

If a student, whose deceased veteran parent had operational service but whose death was not war or defence caused, has also lost their other parent, they are also an eligible child. This loss may be through death or where the surviving parent is not maintaining them.

A student who is the child of a Vietnam veteran (or who is or has been dependent on a Vietnam veteran) but who does not qualify under any of the above criteria may be eligible in certain circumstances.

Who is a child of a veteran, member or former member under the VCES?

A child of a veteran, member of the Forces or member of a Peacekeeping Force can be:

- a biological son or daughter or an adopted son or daughter of the veteran or member: or
- a child who is wholly or substantially dependent on the veteran or member, including, but not limited to:
- a child who by law the veteran or member is liable to maintain; or
- a child who is in the care of the veteran or member and for whom the veteran or member is legally responsible for day-today care, welfare and development; or
- ♦ a child who is wholly or substantially in the veteran or member's care.

Under the MRCAETS, an eligible child is someone who is:

- under 16 years old; or
- between the ages of 16 and 25, undertaking full-time education and who is not ordinarily engaged in full-time work on his or her own account; and
- has been compensated as an eligible young person under the MRCA for the death of a deceased member of the ADF;
- is the dependant of a member or former member who is eligible for the Special Rate Disability Pension safety net payment (SRDP); or
- is the dependant of a member who has satisfied the criteria for eligibility for SRDP at some point in their life; or
- is the dependant of a member or former member who is eligible for maximum permanent impairment compensation under the MRCA (assessed at 80 or more impairment points).

ATTENTION ALL.

Hi.

My name is Geoff Clark and live in Golden Grove, South Australia, and was a 9 Squadron RAAF Helicopter Crewman in Vietnam from February 1968 to February 1969.

I am trying to trace 2, maybe 3, 35mm colour slides that were lent to the Vietnam Veterans' Association in Walkerville, South Australia, at about the time of the "Agent Orange Royal Commission" hearings in Adelaide.

At that time, VVAA had a president who had a surname of Tudleman or similar and he was a naturopath. They were never returned and have not worried about them till now, but circumstances have changed. These colour slides were taken at Fire Support Base Coral on the 16th May 1968.

One of the slides shows two dead Vietcong on the side of the helipad, one with "horrendous" wounds to his stomach where an ammunition magazine exploded, and the other slide is of the Mass Burial Pit which was had many bodies inside. It was taken from the helicopter.

I have attached rough, (and I mean rough), drawings of the contents of the slides.

I have contacted the Australian War Memorial, but they have no record of either of the images.

magazines and give my contact details as:



"SAY WHAT YOU FEEL FOR OTHERS IN THEIR LIVING YEARS"

Like many others, I have, over my lifetime, seen the passing of family members, fellow comrades, colleagues and close friends. Many of whom I loved, respected or admired, but had never told them so, when they were alive.

I have listened to the kind and sincere words spoken at the Eulogies and Wakes of those who have left us, and of the many loved ones and those who were paying their respects, that had later expressed their sorrow and regret for not having shown or conveyed their feelings, to those that have departed, during their living years. I would be the first to admit that I had been guilty of this in the past, but no longer.

I believe that many of us have been reluctant to express our feelings for others, for fear of it being taken the wrong way, that it may be embarrassing to the other person or that we are just frightened to say so, or just don't know how to express these feelings. Perhaps you could write a personal letter, say it to them personally, put your arm around their shoulder, or just give them a "hug" and let them know that you love, care, admire or respect them for whatever the reason might be.

An expression of these feelings does not hurt anyone, and if anything, it may make that other person feel so much better about themselves, or yourself. So do it, if that is how you feel, you may be surprised at the difference this makes. Let you heart lead the way you may wish to express your feelings.

I have three children (boys), a young boy of 23 years and two older boys who are now in their 40's. They have not been "angels" growing up, but they have expressed and shown their love to me on many occasions, and to this day. Although my two older boys are in their 40's they regularly give me a "hug", the occasional peck on the cheek, and tell me that they love me and that I am a good dad (sometimes debatable). That is all I ask and need of my children, and it makes me feel good.

Should I pass away suddenly tomorrow I will have done so, happy in the knowledge that my children have shown and expressed their feelings for me, and I them, during my "living years".

If you genuinely love, care, admire or respect someone, be it family members, comrades, colleagues or close friends, let them know of these feelings, in whatever way you like, or are comfortable with — In their living years.
