## Posttraumatic Stress Disorder Very Long Road to the Right Decision

It was a great win that

here they are, infantry patrolling round the Long Hi mountains or out from Tarin Kowt.

They know there have been plenty of mine incidents there. In fact they have a splinter team of engineers with them trawling for mines or maybe there's someone out front prodding with bayonet to clear a path.

And there's the casevac helicopter fitting itself into an improvised landing zone, its rotor blades clipping the branches. Or perhaps it's balancing with one skid on a rock and the other in mid-air for fear of detonating mines on the ground. The crew has

taken these risks before to get the wounded to safety.

And there's the engineer, laying mines, lifting mines, defusing booby traps, clearing tunnels with a pistol and torch.

And what about the sailor. It's the Gulf War and the enemy threatens his ship with Exorcet missiles and chemical agents. He fears being trapped below the waterline.

The thing is, they may not tread on a mine, or crash the helicopter or set off the booby trap or be hit by a missile but they all know they are in real danger of those things happening. They know there is a real threat to their lives and the

lives of those around them in

those dangerous environments.

The Vietnam Veterans Federation has believed for a long time that such experiences should accepted as the cause of Posttraumatic Stress Disorder, but they have not been. What has been necessary for acceptance has

As readers may know, the Repatriation Medical Authority puts out lists of causes of illnesses known as Statements of Principle. experts known as the Specialist Medical Review Council.

So we immediately appealed arguing that the causes of Posttraumantic Stress Disorder should include the threat of serious injury or death and working in a malevolent environment, regardless of whether or not a life threatening event actually materialised.

The Repatriation appeals system does not, as many veterans can attest, move quickly. It was not till December 2010 that the Vietnam Veterans Federation was asked to answer a series of questions to clarify its position.

There followed exchanges of our claims and the Repatriation Commission's counter-claims and it was not till March 2012 that a hearing was held where VVFA National President Tim McCombe and scientific advisor, the eminent Dr Brian O'Toole, presented our case.

Having heard all the evidence and the concerns of the Repatriation Commission, the Specialist Medical Review Council made its decision.

At the standard of proof required for war and peacekeeping service (operational service) the Council came down on the side of Tim McCombe and the Vietnam Veterans Federation.

What the Council decided can be summarized as follows:

That Posttraumatic Stress Disorder might be caused by a person having a reasonable perception of threat and/or harm to the integrity of the self or a colleague as a consequence of being in any or all of a threatening, hostile, hazardous and/or menacing situation and/or environment.



And can you tell me, doctor, why I still can't get to sleep? And night-time's just a jungle dark and a barking M16?

(Pension officers and Advocates should view the full wording now in the Statement of Principle at http://www.rma.gov.au/SOP/main.htm\_)

It was a great win that will have a profound effect on the way compensation claims from veterans of the conflicts in Somalia, Rwanda, Timor, Iraq and Afghanistan are judged.

There is, however, room for interpretation and we are yet to see the guidelines produced by the Repatriation Commission for its Determining Officers. Perhaps the Repatriation Commission will attempt to squeeze the good will out of the decision by weasel-wording its guidelines. We hope not.

#### That's not the end of the story

And that's not the end of the story, or more correctly, that's not the beginning.

The story starts in 1994.

Before then, the Department decided on the causes of illnesses. If they rejected a veteran's claim for compensation on these grounds, the veteran could appeal to a tribunal, bringing along a medical expert to plead his case at the hearing.

In 1994 the Federal government moved to change this system. It introduced legislation establishing an independent body called the Repatriation Medical Authority. Its highly qualified members were to look at all available

medical evidence and decide on the causes of illnesses.

But the legislation did not include the right to appeal against the findings of the Repatriation Medical Authority.

This was disturbing to say the least.

Tim McCombe and the late (and very much missed) Ray Fulton went straight to the Shadow Minister for Veterans Affairs, Senator Jocelyn Newman and advised her of this omission. As the government lacked a majority in the Senate, Senator Newman was able to block the passage of the legislation, sending it to a Senate Committee of Enquiry. Now alerted to the danger, all the major ex-service organisations argued before the Committee for an appeals body to be included in the legislation.

The government conceded and included the establishment of the Specialist Medical Review Council.

So far so good but in the Senate debate Senator Lees expressed a concern.

are no undue delays in the consideration of appeals..."

It would, of course, be up to the Repatriation Commission to ensure this promise was kept.

#### That's still not the end of the story

In March 1995 the RMA produced the list of causes of prostate cancer in a Statement of Principle (SoP) but did not include smoking as one of those causes.

Believing the RMA was wrong to reject the

link between smoking and prostate cancer, we lodged an appeal with the Specialist Medical Review Council (SMRC). That was in May 1995.

In January 1996 the Specialist Medical Review Council (SMRC) published its decision. It too rejected any link between smoking and prostate cancer.

But something was wrong.

Readers will know that the law provides for a special standard of proof when dealing

with compensation claims from veterans with war or peacekeeping service. It is a standard of proof less onerous than that of a court.

We studied the Reasons for Decision and realised that the SMRC had made a fundamental mistake; it had not used the standard of proof applying to war and peacekeeping veterans in reaching its decision.

So we appealed the SMRC's rejection to the Federal Court. In November 1996, Justice Tambline ruled that, under the law as it then stood, his court did not have the jurisdiction to hear the case.

Immediately we transferred the case to the Supreme Court of NSW, but two years passed before the case was heard (August and September 1998). Another half year passed before the decision was delivered by Justice Greg James.

It was, however, a decision worth waiting for. In strong terms, Justice James agreed with our contention that the wrong standard of proof had been applied. This meant the case would be sent back to the SMRC to be reviewed using the correct standard. Or so we thought.

The Repatriation Commission, however, had other ideas. It appealed the decision to the NSW Court of Appeal. When challenged as to why it would take an action that would hold up a decision effecting hundreds, perhaps thousands of WWII and other veterans and their widows, the

Repatriation Commission claimed that, while it accepted the main decision on the standard of proof and the need to send the case back to the SMRC for review, there were peripheral issues that needed clarification.

More time passed. More time wasted. More WWII and other veterans died without knowing whether or not their wives would or would not become War Widows.

It was the best part of

another year before the case was heard.

When the case eventually came before the court, did the Repatriation Commission confine its arguments to peripheral issues? No it did not. Contrary to its pledge it argued that the standard of proof used by the SMRC was correct. Perhaps it hoped to gain advantage by springing a surprise.

But this deceit did it no good. When the judgment was delivered in March 2000 by Justice Jim Spigelman heading a bench of three judges, it came down firmly on our side and sent the case back to the SMRC.

More than a year passed before the SMRC revisited the decision. In August 2001, it declared it had not changed its mind; it still denied there was a link between smoking and prostate cancer.

But as far as we were concerned, the SMRC had done it again; it had employed the wrong

standard of proof. It was very frustrating.

We appealed the SMRC decision to the Federal Court, which, because of a legislative change, was now able to hear the case.

Again time passed without a decision on whether or not those hundreds, perhaps thousands of veterans or their widows could apply for compensation.

It was not till June 2002 that Justice Moore brought down his decision. To our way of thinking it was a strange one. Whilst saying the wording of the SMRC decision did not obviously point to the correct standard of proof being applied, neither could he point to wording which showed it had not. He therefore found against us.

Not surprisingly, with the decision being so wishy-washy, we lodged an appeal with the full bench of the Federal Court.

The full bench of the Federal Court is an eminent body indeed. Its decisions are not taken lightly. The three judges hearing the case were Justices Branson, Emmett and Stone.

They brought down their judgement in November 2002. It was another one worth waiting for, confirming, as it did, that the SMRC had applied the wrong standard of proof.

Now there was the opportunity to decide the matter. It could go back to the SMRC which would follow the steps carefully and clearly laid down for it by the court. Surely, we thought, it would be in everyone's interests for that to happen.

But not, apparently, in the interests of the Repatriation Commission. It was not playing. It had a dirty trick up its sleeve in the form of a legal technicality. It pointed out to the court that the RMA had put out a new Statement of Principle listing the causes of prostate cancer, again rejecting any smoking-prostate cancer link. The Repatriation Commission argued that this new Statement of Principle superseded the previous one on which the years of court hearings had been based. Because that old Statement of Principle was superseded, the Repatriation Commission argued, all the decisions made by the courts over the last eight years were now null and

void.

The judges found in the Repatriation Commission's favour on this technical point. It

meant that the process would have to start again from the beginning.

Eight years of court cases for nothing.

Of course the Repatriation Commission did not have to present this argument. It could (and should) have been as keen as we were for the matter to be resolved. The Repatriation Commission should have let the case go back to the SMRC for resolution. But instead it blocked the process. We can find no other explanation than that the Repatriation Commission wanted to prevent the possibility of those veterans and their

widows receiving compensation. We can find no alternative to labeling the Repatriation Commission's action as an act of bastardry.

O f course the Repatriation Commission's ploy made a farce of the appeals system. No matter to what point any appeal might progress, the RMA producing a new Statement of Principle would make all that progress null and void, making the appealing ex-service organisation start all over again.

A dog chasing its tail.

But we had no option but to start all over again.

In 2005 Tim McCombe again presented our evidence to the RMA.

The RMA again rejected the link and we again appealed to the SMRC.

In May 2011, the SMRC began hearing the appeal.

Yes, that's right, 2011. It took six years for the SMRC to get round to hearing the appeal on an issue vital to the future of so many veterans and their widows.

This was clearly not what the government had promised back in 1994, not what the Repatriation Commission should have ensured.

But this time, with the steps so clearly laid

down by the Full Bench of the Federal Court, the SMRC applied the correct standard of proof and decided that smoking and prostate cancer were linked.

The SMRC now follows the steps laid down by the Full Bench of the Federal Court in all its reviews.

It was because of this that we were able to our appeal in the recently decided Posttraumatic Stress Disorder case.

Yes, our recent appeal in which we had 'threat to life' and 'malevolent environment'

> included as causes Posttraumatic Stress Disorder could not have succeeded or even been made, but for those fights we had starting in 1994.

Makes you wonder.

#### But the fight's not over.

The Repatriation Commission still clings to rules that make appeals system dysfunctional.

They cling to the rule that the SMRC may only use the evidence available to the RMA

when it made its decision.

Our recent appeal on PTSD was initiated in 2008. It was not heard till 2012. In that gap important new evidence emerged. The SMRC was not allowed to use that evidence in making its decision. If our appeal had failed, we would have had to start again even though with the new evidence our appeal would have succeeded.

They also cling to the rule that no matter to what stage an appeal has progressed, it is made null and void should the RMA produce a new Statement of Principle on that illness. Those appealing have to start the process all over again instead of the new Statement of Principle simply replacing to old and the appeal proceeding.

These absurdities can add and have added years to the duration of an appeal.

Why are they doing this to us?.

## Our New Minister Senator the Honourable Michael Ronaldson

t's a great relief when a good Shadow Minister for Veterans Affairs remains in that portfolio when the Opposition wins government.

This is the case with Senator the Hon

Michael Ronaldson. He and his off-sider Robert Hardie made every effort Opposition to understand veterans' issues.

More than that. Michael Ronaldson went in to bat for us, both in Senate Estimates Committee hearings and in the Senate itself.

There was an issue about which we felt strongly. We believed Counselling Service clients deserved privacy; they should be able to enter a counselling centre, have

counselling and leave the centre without mixing with veterans and families visiting departmental offices. In Darwin, Lismore and Southport such privacy was sadly lacking. But the Repatriation Commission dismissed our demand that changes be made to afford privacy by stating veterans and their families were happy with the existing situation. Their intelligence source was certainly different from ours.

Senate Estimates Committees call senior

bureaucrats before them to answer questions. Senator Ronaldson was a member of the committee which brought before it senior bureaucrats of the Department of Veterans

> Affairs. It was, we believe, his forensic questioning of them on the issue of counselling centre privacy embarrassed the Repatriation Commission into action.

> Now the situation in Darwin and Lismore is satisfactory, while action has been promised in Southport when the centre's lease expires.

> In late 2011 a particularly odious piece of legislation came before the Senate. It gave the Repatriation Commission unrestricted powers on off-setting

compensation payments. For instance, take a veteran who has, some years previously, injured his ankle and received compensation. Now, he injures his knee. He is again compensated. However, under the new rules, the Repatriation Commission could 'off-set' the second payment against the first by saying that both injuries contributed to the same incapacity, namely, the 'mobility of the leg'.

In the end, the Senator didn't have the

numbers to defeat the bill but did drag assurances from the government that guidelines preventing any such abuse would be drafted in consultation with the veteran community.

Then there is, of course, Michael Ronaldson's advocacy for military superannuation to be more fairly indexed. Over some years, the Senator introduced bills into Parliament seeking to give fairer indexation to military superannuants over 55 years of age. Indeed, it became a promise that should the Opposition win office at the 2013 Federal election, its first budget (May 2014) would include the change.

There are those who point out that this proposal unfairly excludes military superannuants under 55, does nothing to change the out-of-date life expectancy tables being used, fails to increase the percentage of superannuation payments for widows to align them with the more generous percentage paid to many parliamentarians widows, fails to make these pensions non-taxable in line with many other retirement pensions and certainly does nothing to remedy the money foregone while unfair indexation of military superannuation pensions have eaten away at their comparative value.

But fairer indexation for over 55s is a start and a most welcome one at that.

We shall continue to talk to the Minister about moving forward from this promising initiative.

Ex-service organisations that process compensation claims and provide advocates for appeals against claims rejected by the Repatriation Commission are eligible for some financial help from the government. The help only covers a percentage of the cost but it allows for a speedier service. Several years ago these funds were cut by about a quarter, putting enormous pressure on exservice organisations straining to keep up with increasing workloads.

Amazingly, the new Minister has been able to restore this diminished fund. The extra money, or at least part of it, will go towards improving the pension officer and advocate training system.



What we found with Senator Ronaldson when Shadow Minister was that he listened and wanted to understand. And more than that, he was willing to take on the Repatriation Commission when he thought they were in error.

We hope this continues because we see the Repatriation Commission in serious error in its attitude to two issues in particular.

The first is their unexplained refusal to contemplate fixing the irrational rules regulating appeals from decisions of the Repatriation Medical Authority to the Specialist Mediical Review Council; rules that make the system dysfunctional. (see previous article)

The second is the Repatriation Commission's refusal to take seriously the need to formalise arrangement for child care for young mums visiting the Counselling Service. We must, after all, do everything possible to prevent a repeat of that shocking statistic that the children of Vietnam veterans have had a 300% higher suicide rate than their peers in the general community.

ONY EASTLEY: The wives of Vietnam veterans who saw their husbands come back from the war bearing the mental scars of the conflict are urging the families of soldiers

returning from Afghanistan to seek help.

The wives say that many women married to Vietnam veterans waited more than 30 years to seek assistance. They don't want that same pattern repeated again.

Research shows the spouses of Vietnam vets have rates of some mental disorders more than 30 times the national average.

With more here's social affairs reporter Sally Sara.

SALLY SARA: The wives

of some Vietnam veterans call it walking on egg shells. It's something they've done for decades: trying to keep their families going, while their spouse is affected by post traumatic stress, depression or anxiety.

Pat Cleggett from the Partners of Veterans Association of Australia hopes that the partners of Afghanistan veterans won't have to suffer in isolation. <u>PAT CLEGGETT</u>: We might be a generation apart in age, but we've walked the walk. We've lived the life. We can offer them some avenues of where to go for help if they don't already know.

Well we're certainly finding that the wives have a very much higher rate of depression. More than half of the women have... would qualify for a depressive disorder. Now that's pretty nasty.

SALLY SARA: Mrs Cleggett says while it took a long time for the psychological injuries of Vietnam veterans to be acknowledged, it took even longer for people to understand that the spouses and children were deeply affected too - not just affected by the experiences of the veteran, but in their own right.

She says many wives kept quiet for decades about the challenges of supporting husbands who had been changed by war.

PAT CLEGGETT: The

walking on eggshells has been a horrendous thing for a lot of girls. It took me even a while to learn what... when I was pushing his buttons without realising it.

But we have to keep our own self esteem at the same time. We can't be walked over. We've got to be supportive without being sort of trampled on.

New data has been released from a national study on the mental health of partners of Australian Vietnam veterans.

Dr Brian O'Toole from the Brain and Mind Research Institute at the University of Sydney is one of the lead authors. He says 12 per cent of Vietnam veterans' partners are suffering from severe, recurrent depression.

<u>BRIAN O'TOOLE</u>: And that's 33 times higher than in the general Australian population - not 3.3 or 33 per cent, but 33 times higher.

<u>SALLY SARA</u>: Some initial results from the study were released in 2011 but Dr O'Toole says further data is now showing the depth and breadth of the problem for veterans' partners.

BRIAN O'TOOLE: Well we're certainly finding that the wives have a very much higher rate of depression. More than half of the women have... would qualify for a depressive disorder. Now that's pretty nasty.

<u>SALLY SARA</u>: The research is also tracking the mental health of the veterans. Dr O'Toole says 40 years after the conflict, many former soldiers are still suffering.

<u>BRIAN O'TOOLE</u>: If a doctor's got a veteran in their consulting room, check to see if the wife's in the waiting room. Make sure that she's not being overlooked.

<u>SALLY SARA</u>: Pat Cleggett from the Partners of Veterans Association of Australia says the families of more recent veterans must reach out if they are struggling.

<u>PAT CLEGGETT</u>: Don't wait 30 years like a lot of the wives of Vietnam veterans did. Get out there and seek help.

<u>TONY EASTLEY</u>: Pat Cleggett from the Partners of Veterans Association of Australia. Families of veterans seeking help can phone the toll free assistance line: 1300 553 835. The number's on the AM website.

## **National President Comments:**

eterans' war caused psychological damage puts families at risk. It's as simple as that.

Not taking this risk seriously can have dire consequences.

For Vietnam veterans those consequences have been the high rate of depression amongst veterans' wives and the shockingly high rate of suicide amongst their children.

There couldn't be better reasons to get help quickly.

And if you're the spouse of a veteran whose obviously got a problem but won't acknowledge it, go and see the Veterans and Veterans' Counselling Service yourself —before any damage is done to the family. The veteran will eventually thank you for it.

If you're a young mum with young children and no relatives to mind them, just take them along on your first visit. Even counselling with your children present is better that no counselling at all. After that ask what child care arrangements the Counselling Centre might be able to help you with.

And it wouldn't be a bad idea to get in touch with the Partners of Veterans Association. They have a wealth of experience in living with veterans with psychological damage. And their advice and support might just be the thing to set things right.

## Dr Peter Hendy MP Replies

eter Hendy is now the member for Eden Monaro in the Federal Parliament. His personal views on veterans matters have therefore become important to us.

As we reported in the November 2013 edition of this magazine, Peter Hendy was the Chief Executive Office of the Chamber of Commerce and Industry in 2005 when it commissioned a paper proposing government expenditure cuts. Included in those proposed cuts were downgrading of the indexation of veterans' pensions and the abolition of the Department of Veterans Affairs.

Dr Hendy's response to our article follows:

Dear Secretary,

I would like to comment on your recent article entitled *One to Watch.* This article was about a 2005 paper commissioned by the Australian Chamber of Commerce and Industry (ACCI), when I was the Chief Executive of that organisation.

For the record it was a discussion paper prepared by an independent consultant, Mr Des Moore, a former Treasury Deputy Secretary, who wrote a piece broadly about possible budget cuts. It was designed by Mr Moore to be a provocative thought-piece about ways of getting the overall Budget in order.

The key point is it was not ACCI policy and was never adopted as such. Indeed that was communicated by ACCI to your journal at the time. Nor have these policy positions ever been my personal views.



Fast forward eight years and this paper resurfaced during the 2013 federal election campaign in Eden-Monaro when I ran as the Liberal candidate against the ALP incumbent, Mike Kelly. It was circulated by my political opponent at a media event, with the claim that it represented my personal views on taxation, budgets and other policy areas such as Veterans Affairs. A similar false claim has now appeared in your journal. There is also an email doing the rounds in the veterans community which has a concocted email purportedly from me which quotes me advocating reducing service pensions and abolishing the DVA- both claims being absolutely false and defamatory. Can I suggest the political games continue. Clearly there is an orchestrated campaign afoot. But to create anxiety in the veterans' community in this way is a low act.

All I ask as the new Member for Eden-Monaro is that the Coalition is judged at the end of this term by what it has delivered for Veterans.

#### Dr Peter Hendy MP is now the Member for Eden Monaro in the Federal Parliament. His personal views on veterans' matters have therefore become an important matter to us.

Labor had six years to sort out the pension issue for Veterans and squibbed it. In fact when in Opposition the Coalition put an increase in Veterans entitlements up in a Bill and Labor voted it down!

As we said during the campaign, a Coalition government will ensure that DFRB and DFRDB military superannuation pensions are indexed in the same way as aged and service pensions. Our commitment will apply to DFRB and DFRDB superannuants aged 55 and over. Under the Coalition, 57,000 military superannuants and their families will be better off.

I just wanted to set the record straight.

#### We responded to Dr Hendy's letter as follows:

Dear Dr Hendy,

Thank you for your letter concerning the article titled, *One to Watch* in November 2013 edition of our journal.

It is comforting to know that you disagree with Des Moore's proposal that the indexation on Veterans Affairs pensions should be made less generous and that the Department of Veterans Affairs should be abolished.

Your letter suggests that we should have known of your disagreement.

We refer to a statement by you about the cuts proposed in Des Moore's paper reported in the Sydney Morning Herald on 2 May 2005 in an article titled, *Old, sick to pay for ACCI tax cuts.* The article reads as follow:

Chamber chief executive Peter Hendy said

if people wanted tax reform, they also had to find ways of funding it.

"It is just not possible to legitimately talk about taxation reform in this country without also looking at major expenditure cuts," he told reporters.

"If you want to talk the talk on tax cuts you have to walk the walk on expenditure cuts.

"The reason it needs to be done because we need major tax reform in this country."

No hint there of disagreement.

In The Adelaide Advertiser, 18 May 2005 in an article titled *War veterans up in arms over pay reform plan*, you are reported as saying:

"The report includes challenging proposals across the board, including a 20 per cent cut to business welfare."

It seems to us you were saying that if business welfare was cut by 20 per cent, that we all should be willing to cop cuts.

These statements suggest that far from disagreeing with the cuts proposed in Des Moore's paper you were an apologist for them. We therefore feel justified in our concern.

However we are pleased our concern is unwarranted as you make clear in your letter that you do not support Des Moore's proposed cut for veterans.

As for the election, we played no part in it. If there are any orchestrated political games afoot, we are playing no part in them.







Re Meentheena Veterans Retreat I have just enclosed a little info on a veterans retreat being established at Meentheena, an old abandoned cattle station 75Kms east of Marble Bar, along the Nullagine River. The retreat has a dirt airstrip for light aircraft and the Flying Doctor craft. There is a full medical emergency kit and first aid room. There is limited accommodation at present as it is our intention to establish several camping sites along the river for your own bit of privacy. So you are welcome to pull up with your camping gear or caravan anytime soon. We hope to have a Main Camp site completed as a get together for 'Happy Hour'.

It's a safe place along the river to relax on the banks, swim without Crocs, or just fish away the day. You might even like to try your hand at prospecting (Miners license required), as there is gold in the area. There is a Campsite host who lives in-situ, and is willing to show visitors around for a small fee, to cover the cost of fuel.

The camp is powered by solar energy with conversion to 240v. Water is supplied via a bore, and we have established 3 caravan shaded areas adjacent to the main camp, with plenty of sight-seeing to do from there. All food and fuel must be brought with you and all litter removed as you leave.

It's a great place for those who enjoy relaxing, watching the wild life, or taking in aboriginal paintings and carvings.

Dear Sir,

I was interested to read the articles re the use of insecticides in Vietnam in the Nov/Dec 2013 Journal. The information did not surprise me and proper exposure of this issue is long overdue. However, in discussing pesticide use in the AUS Army bases in Vietnam, the articles do not cover the effects of pesticides on the personnel of No. 2 Sqn, RAAF while based at Phan Rang (USAF Base South of Cam Ranh Bay).

I served approximately 12 Months with 2 Sqn during 1970/71 during which time the base was sprayed with insecticide on a weekly schedule. The spraying was done by a Phan Rang based 'Ranchhand' Squadron which was otherwise engaged in spraying the defoliant 'Agent Orange'. Done shortly after dawn, the C-123 pilots (fellow aircrew and known to us) always delighted in flying very low over the roofs of our double story plywood hoochies to advertise their presence. The concentration of insecticide which entered the quarters generally required breathing through a towel for some time afterwards in an endeavour to reduce the adverse effects until it dispersed. Although I have no idea what insecticide was used, the declared intention was to reduce the risk of malaria. The Base perimeter exterior was also sprayed occasionally with Agent Orange to aid security by ensuring that no foliage cover was available to potential enemy infiltrators.

I, and many of my Squadron colleagues, were subsequently afflicted with prostate cancer, one (to my knowledge, but probably more) fatally, and my eldest son, conceived after my return to Australia, is disabled. My treatment was accepted by DVA as war-caused.

I applaud and thank you for highlighting the issue of insecticide use in Vietnam.



# Stories of our scholarship children and grandchildren

(How proud we are of them all)

he Vietnam Veterans Peacekeepers and Peacemakers Association of Australia (NSW Branch) Inc., affiliated with the Vietnam Veterans Federation of Australia, funds two Phil Thompson Scholarships for the children and grandchildren of Vietnam veterans and the veterans of more recent conflicts who are doing it tough financially. The scholarships are \$3,000 a year.

The Scholarship is available nationally and membership of the Association is not a requirement.

Phil Thompson was a highly respected leader of the Vietnam Veteran movement campaigning in the early 1980s for a Royal Commission into exposure to Agent Orange and for veterans' counselling centre. He sadly was to succumb to war related illness.

We fund these Scholarships mainly from the proceeds of the Association's Annual Raffle. So please help by buying tickets.

The Scholarships are administered on the Association's behalf by the Australian Veterans' Children Assistance Trust (AVCAT), who also administer other Scholarships funded by the Australian Government (Long Tan Bursaries) and sponsors such as Legacy, RSL, TPI and a number of other organisations.

AVCAT usually calls for applications for these Scholarships in August of each year, with a closing date of 31 October of the same year. The scholarships that are on offer, and the eligibility requirements of the various scholarships, will be advertised by AVCAT in this magazine prior to that date.

#### Stephanie BARKER

Stephanie was awarded the Phil Thompson Scholarship in 2008 for three years. She graduated with a Bachelor of



Physiotherapy degree from La Trobe University in 2010 and worked as a rural community health physiotherapist at Alexandra District Hospital.

In 2012 Stephanie took a position as the sole Acute/Rehab/Surgical physiotherapist near her home in Healesville Hospital, 52 kms north-east from Melbourne's CBD in Shire of Yarra Ranges. She also finds time, about 8 hours a week, working in community health.

Down the track Stephanie hopes to do further study in her field in management courses and moving into physiotherapy management/team leader roles.

Stephanie is the child of a Vietnam Veteran who served with 21 Engineer Support Squadron 1968-69.

Caitlin was awarded the Phil Thompson Scholarship in 2009 for three years. She graduated with a bachelor of Communication degree from the University of Newcastle in 2011. She then went on to do an Honours degree in 2012. She received the faculty medal and the university medal for first place in the Communication Honours program.

Caitlin is currently in her first year of a four year PhD in Communications at the University of Newcastle and hopes to remain in academia and take a lectureship at the University when she finally completes her studies.

Caitlin passed on her gratitude for the assistance given by the Association through the Scholarship which helped her with the undergraduate degree.

Caitlin is the grandchild of a Vietnam Veteran who served with 2 APC Squadron in 1972.

#### Nathan SHUTE

Nathan was awarded the Phil Thompson Scholarship in 2010 for three years. He graduated with a Bachelor of Design in 2011 and will complete his Master of Architecture in 2012, thanks to the support of the University of South Australia, allowing him to attend as a visiting student (from the Queensland University of Technology).

Nathan is currently working with "Design Inc" in association with Silver Thomas Hanley Health Architecture in Adelaide on one of the largest projects currently in Australia – The Royal Adelaide Hospital –

due to be completed and occupied in 2016.


It is pleasing to see what our past scholarship recipients have achieved since completing their studies. The achievements of both our past and present recipients only highlights their determination to succeed under hardship.






Operation Life workshops' emphasis is on suicide prevention – they aim to help members of the veteran community to recognise someone who might be having thoughts of suicide and to link them in with appropriate help. There are three types of workshops:

- Suicide alertness for everyone: (Safetalk) half day presentation.
- Applied Suicide Intervention Skills Training: (ASIST) - Two-day skills training
- Applied Suicide Intervention Skills Training Tune-up: (ASIST Tune Up) - half day refresher workshop

Workshops are open to people who are concerned about veterans, their family, friends or mates in the veteran community. Welfare, pension officers and other helpers from ex-service organisations and the veteran community are encouraged to attend
